Dear Camper;

Welcome to Lake Georgetown. We want you to have a safe and enjoyable visit. The following are some answers to Frequently Asked Questions (FAQ). If you have any other questions during your visit, please contact a Park Host, a Park Ranger, or the Project Office (Monday through Friday, 8:00-430pm) at 512-930-LAKE (5253) or address above.

**FAQ.**

- 1- **How long may I camp?** You may camp up to 14 days during any 30-consecutive-day period at any one water resource project (that includes all parks at Lake Georgetown). (ref: Title 36.327.13 (a)).
- 2- **Do I have to make a reservation?** Yes, reservations are **required** at each park, either for camping or a Daily Activity Pass. They can be made at either [www.Recreation.gov](http://www.Recreation.gov) or call the National Recreation Reservation Service at 1-877-444-6777. Reservations for a campsite may be made up to 6 months in advance **and up to 12 months in advance for group facilities.**
- 3- **What are the park hours?** The park gates open at 6am and close at 10pm. The gatehouse hours vary; please check with the individual parks. Quiet hours are 10pm to 6am. Check out time is 2pm.
- 4- **May I use my Golden Age/Golden Access/American the Beautiful card?** Yes. A cardholder will receive a 50% discount on camping fees. Additional information about each pass can be obtained at <https://store.usgs.gov/pass>.
- 5- **Is there a campsite capacity?** Most campsites are designed to accommodate 8 to 10 people.
- 6- **May I have visitors?** Yes. Visitor hours are from 6am to 10pm. They **MUST** pay for a Daily Activity Pass at Recreation.gov.
- 7- **Where can I park?** All vehicles and trailers must be parked in designated areas to help protect the natural environment you came to enjoy.
- 8- **May I have a campfire?** Yes, please check at gatehouse to make sure Williamson County is not under a burn ban. You may have a fire only in locations where cookers or fire rings are provided. Please bring your own firewood. Remember fire safety, attend your fire at all times, and completely extinguish it upon departure. Cookers are not permitted in swim beach area.
- 9- **Where do I dump my trash/waste (black/gray water)?** Please dump trash in the dumpsters that are located in the parks. A trailer dump station is located at Cedar Breaks and Jim Hogg Parks for emptying trailer-holding tanks.
- 10- **May my pet camp with me?** Yes. Your pet must be restrained at all times when in the park, including on the trails. Leashed must be no more than 6' in length. Any waste produced by your pet must be picked up and disposed of properly. Animals and pets are prohibited on the swim beach area.
- 11- **May I have a firearm in the park?** No, the possession of a firearm is prohibited. (ref: Title 36.327.13(a)).

While visiting our parks, please observe all the park rules in order to ensure your visit is enjoyable while protecting yourself, others, the park, and the environment. A copy of the park rules and regulations is available at the gatehouse, Project office, or Lake Georgetown website ([www.swf-wc.usace.army.mil/georgetown](http://www.swf-wc.usace.army.mil/georgetown)). We hope your stay with us is enjoyable and you will return often!
