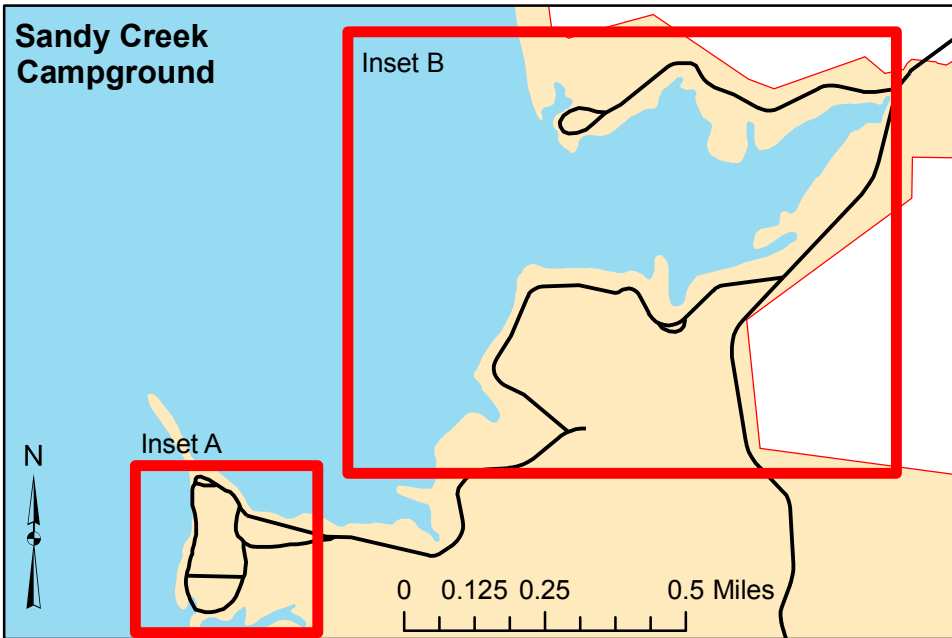

RULES AND REGULATIONS

Each campsite is limited to two (2) camping structures, such as two tents, one trailer and one tent, or a pickup camper and one tent. Two trailers (any wheeled unit) on one site are not allowed. Maximum site occupancy is limited to eight (8) persons (adults and children). Camping is permitted at designated sites only and is limited to 14 days within a 30-day period. It may be possible to obtain an extension by checking with the gate attendant. Two (2) vehicles only are allowed at the campsite. One (1) boat trailer is allowed.

Please observe quiet hours from 10 pm to 6 am. This includes the operation of generators.

Maximum speed is 20 MPH in the campground.

Keep your campsite clean and deposit all trash in provided cans or dumpsters.

No fireworks are permitted in the park. Loaded firearms are not permitted in the park. Unloaded firearms may be transported to and from designated hunting areas.

Pets must be kept in a pen, cage or leash no longer than 6 ft.

Off-road vehicles and golf carts are not permitted in the park. All vehicles, including motorcycles/mopeds, must be street legal and must be parked at the campsite area or in a designated parking lot. Parking on the grass is prohibited.

No live or standing dead trees may be cut. Dead wood on the ground may be used for site campfires. All fire material must fit in the fire ring and all fires and bar-b-que grill coals must be completely extinguished before departure from the park.

No swimming is allowed at boat docks or fishing piers.

SANDY CREEK PARK

Sandy Creek Park is located on B.A. Steinhagen Lake, Town Bluff Project, approximately 12 miles west of Jasper, Texas. From town, head west on US 190, then south on FM 777 two miles, then west on County Road 155 two miles. The park offers overnight camping and day use facilities.

CAMPING

The park is open year round. There are 77 sites of which 71 have water and electric hookups (35 with 50 amp service). Each site includes a picnic table with shelter, grill, service table, and lantern hanger. A water hydrant is located between the 6 sites without hookups. Sites may be reserved up to 6 months in advance. You may reserve a campsite for future use by calling the National Recreation Reservation Service at 877-444-6777 or on the Web at www.recreation.gov.

FEES

Fees for sites with water and electric hookups are \$16/night for 30 amp service; \$18/night for 50 amp service. Sites without hookups are \$10/night. Screened shelters are \$25 per night. The group shelter rents for \$45.00 per day. If you are not a registered camper, a fee will be charged for boat launching, shower use and dump station use. All fees subject to change without notice. America the Beautiful Senior Pass holders are entitled to a 50% discount, except for use of the group shelter.

SANITARY FACILITIES

There are two waterborne restrooms with showers; one waterborne restroom and one vault toilet located in the park. The park dump station is located one-half mile past the Gate Attendant station. Gray water must be disposed of in the dump station. No sites have sewer hookups.

SECURITY

Visitor protection is provided by controlled access into the campground through a gate attendant station. Gate attendants are on duty between the hours of 6 am and 10 pm. All visitors are required to stop at the gate attendant station for campsite registration and other visitor information. Park maps and other information is available upon request. The park is closed from 10 pm to 6 am and no admittance, other than registered campers and their guests, is allowed after closing. Campers may exit the park at any time. Checkout is 1:30 PM.

BOATING

Three boat ramps are located within the park. Users should be aware that B.A. Steinhagen is very shallow with many submerged logs and stumps in what may appear to be open water. A reduced speed is suggested to prevent damage to boats and motors and for your safety. Please maintain idle speed near boat ramps and other boaters or structures. Please observe all water safety and boating rules.

We hope you have a pleasant stay. Please observe water safety and boating rules; when boating, ALWAYS WEAR YOUR LIFE JACKET; when swimming, DON'T SWIM ALONE- HAVE A BUDDY NEAR YOU AT ALL TIMES.
